**Remarks**

On 11/01/2021 at approximately 1714 hours I was dispatched an info call from [REDACTED], [REDACTED]. Call comments stated the RP says she is being tracked by an exboyfriend through spyware on her computer.

I called the RP, identified as Laura OWENS, and she stated she had recently broken up with Gregory GILLESPIE. OWENS believed GILLESPIE was somehow hacking into her laptop as well as her smartwatch, since both had recently been acting up. She had received messages in Whats App from an unknown number that referenced ruining her life and destroying her podcast, which was contained on the laptop. She was able to recover all the data from the laptop, so she was not affected by the issues to her devices. OWENS did not know how GILLESPIE was doing this, nor did she have any proof it was GILLESPIE doing it, but she stated she believed it was him. OWENS told me she was in civil litigation with GILLESPIE that was still ongoing.

I then called GILLESPIE who stated OWENS repeatedly accused him of things he did not know and could not have done. GILLESPIE also acknowledged their ongoing civil litigation and stated he was not tampering with her devices in any way.

This concluded my involvement in the matter.
