To see people call my abusers "victims" makes me sick (although I know they both come on Reddit and have posted themselves). I would \*\*never\*\* falsely accuse anyone and misuse the system. My abuser did that, and the lawyer he claimed I was impersonating is actually a family friend, who backed me up 100% in supporting documents. My lawyer also wrote the cease and desist letter that was sent to Clayton, and I know a Redditor contacted him to confirm it, which he did. I don't "fake" pregnancies to trap men, which is a horrible thing to be accused of. The two documents that were "leaked" were never heard by the court and were allegations by my AZ abuser in one case and by my CA abuser's brother-in-law in the other. There was never a doubt that I was pregnant in either case. My AZ abuser had the pregnancy personally confirmed to him by One Medical. My CA abuser went to Planned Parenthood with me to get the abortion. I have all of the medical documentation in the Dropbox that I tried to post the other day, but took down after being bullied. So \*\*please\*\* \*\*stop\*\* acting as if there is any other story. Another theory that has been horrible is that I somehow wrote the letter from the stranger I talked about in my speech, did my TEDx, and then asked a woman to take a photo with me for my Instagram. Do you realize how \*insane\* that sounds? As further proof, the woman wrote a declaration for me, which helped me get me RO against him. I've had people message me saying "they" needed to see a sonogram. Clayton has already seen it and that's all that matters to me. I don't owe you guys anything, nor should I have to prove myself when I am telling the truth. Yes, I've been pregnant before and yes I have two restraining orders against vicious men, but that doesn't make me a bad person or equate to me faking a pregnancy with Clayton. I feel sorry for those of you who have chosen to spend your precious time here simply to make a nasty comment, not caring that there is someone who will be hurt by it. My family has been on call since I have spent my week crying for hours over what I have read on this forum. I've finally come to terms with the fact that I don't need to convince the Reddit community of anything, especially when no one cares to read any of the facts/actual documents that I have responded with. The hate messages I have gotten have been atrocious, but I am extremely grateful to the small group of you who have come to me asking if I needed support and saying you believed me. Real judges have believed me based on the abundance of evidence they've been provided with, so I will stick with respecting them and their methods over those used by Redditors, who would prefer to be snarky over uncovering the truth. This has been a unique experience for me because I never understood how maddening it is to see people write falsities about you when you have presented them with evidence. It's a bad place to be.
