Synopsis:

At 1120 hours on 09/27/2023, Laura Michelle Owens called to report that Gregory S Gillespie violated an order of protection.

Preliminary Information:

On 09/27/2023 at approximately 1413 hours, I, Officer Cariveau #1603 was working within the City of Scottsdale in my capacity as a Scottsdale Police Officer. I was wearing the standard-issue Scottsdale Police blue uniform with OBC and driving a fully marked patrol car (3L12).

Call for Service:

I called Laura Michelle Owens regarding a violation of an order of protection via online activity. She said that she learned about this on 09/21/2023 at approximately 1030 hours.

Interview of Laura Owens:

I called Laura who informed me that she believes that her ex-significant other, Gregory Gillespie has been leaking information to the press in an attempt to harass her.

Laura shows with an active / served Order of Protection OCA/ FN2022052111 / PNO/ AZ2022-94699 between Gregory Gillespie (defendant) and herself (protected person).

Laura alleges that Gregory had obtained a copy of court records from a case (Superior Court of State of California, County of San Francisco, Unified Family Court, Court No: FDV-18-813693) where allegations had been made of Laura faking a pregnancy in a past relationship. She described this document as allegations that were brought up in court, but one page of a 220-page court record. Another document is from a case between her and Gregory. She alleges that Gregory has sent this private court document that he obtained through discovery to several news outlets and tabloids such as "Page 6, people.com, and Daily Mail, US Magazine." She said that he is leaking the above court documents "out of context."

She also alleges that Gregory has also divulged court records to a Clayton Echard, another person in which Laura is currently in a paternity case.

Laura believes that Gregory is divulging these private court records in an attempt to harass and slander her image. These allegations have been part of stories published by these tabloids. Based on this, she believes that this constitutes harassment pursuant to her Order of Protection.

Laura said that she received the court documents from a Reddit user who had written about the case (username:) who sent her the documents. She said that regarding the San Francisco case, only her and Gregory had been granted discovery. She recognizes the nature of the scanned document to be unique to only her and Gregory.

I have no further involvement in this matter.

I received a message from Laura Owens who informed me she had located what she believed a falsified Order of Protection (OOP) posted by Reddit user '______." The document, which she located on "thebachelor" subreddit was uploaded to evidence.com.

Using AZPoint, I located a matching unserved / expired OOP between Gregory Gillespie (protected person) and Laura Owens (defendant).

I informed her that the order was legitimate, but unserved / expired.

Laura believes that this is a further violation of her OOP.

I have no further involvement in this matter.

I was working in my assigned capacity as a detective with the Domestic Violence Unit. I was conducting follow up on the listed case. I had received this case as an Aggravated Harassment case. Victim Laura Owens claims the offender Gregory Gillespie was posting about her on the social media website Reddit under pseudonyms.

I contacted Laura over the phone to inquire further about her claims of being harassed. She told me that Greg is using made up profiles and uploading them to reddit. She also explained how a user had posted to Reddit an order of protection that Greg had against Laura that was never served. Laura told me that the only way someone could get this is if the plaintiff went to court and got the documents. Laura told me there was a reddit user showing that process picture by picture.

Laura told me that she had called the Dreamy Draw court clerk Manny Vargas who confirmed Gregory Gillespie had come into the Dreamy Draw Justice Court and got the documents from him. Laura sent me a voice recording of her speaking to Manny who was heard telling her only the plaintiff could have access to an unserved document.

I told Laura to send me the images of proof she had that Greg was using multiple fake profiles to harass her. Laura sent me a PDF document containing 34 pages of images and text outlining these connections.

I contacted Manny over the phone to determine if he did know that Gregory Gillespie had come into the court to get his paperwork. He advised me that he did not know who that was. He did not know who Laura Owens was either. After I explained the situation, he advised me that he did remember an email about this situation, but other than that nothing was out of the ordinary. He told me it was true that an unserved order of protection would not be given out to anyone other than the plaintiff but did not recall anyone in particular coming to the court to get this order of protection.

I looked at the document send to me by Laura. In the document Laura provides screenshots and photos then has text underneath explaining the connections to Greg. Many of the shown profiles were that of anonymous reddit users posting negative things about Laura. I looked into several of these profiles. Reddit shows a username in the style of "u/username". When you go to the profile of a reddit user you can see when their profile was created and what subreddits they post on. The social media site is broken down into "subreddits". There are subreddits for many different topics to include the "BachelorNation"- a subreddit discussing the personal lives of the TV show the Bachelor contestants.

As of this writing the BachelorNation subreddit has 56 thousand members. Many of the negative comments about Laura were written on that particular subreddit. It should be noted that for an unknown amount of time Laura herself would go to the BachelorNation subreddit and argue with other profiles about their thoughts on her. This could be one reason why she has so many negative comments about her. Laura posted by the name of u

. Laura goes on to claim that many of these profiles were Greg posting about her with knowledge only he could know however many of the profile she claims are Greg were created many years ago.

Laura has listed several profiles as being Greg:

Due to the wide range of accounts that were created from 2016-2023 it is unlikely they are all Gregory Gillespie.

One particular claim is that posted pictures of an anonymous redditor posting pictures showing they were at the Dreamy Draw Justice Court to get the order of protection that Gregory had against Laura. Laura told me this was proof the Greg was , however when I went to the profile page of there were no pictures posted from their account. reposted the pictures and cited an anonymous redditor. On pages 08-13 on the PDF Laura sent me appears to show that it is from the user

Laura then made me aware there was a subreddit dedicated to her specifically called "LauraOwens". Laura claimed this was more cyber bullying by either Gregory or a man named Clayton Echard. When I looked up the subreddit I could see there were 451 people subscribed to that page and numerous posts each day about her from various reddit users. I could not see a clear connection to Gregory Gillespie in any of these posts made on reddit.

I spoke with Gregory on the phone and asked him about the situation. Greg denied having any reddit accounts and told me, "I never had a reddit account". He also told me that he did in fact go to the Dreamy Draw Justice Court to have the previous Order of Protection against Laura for a civil trial he is currently dealing with. He told me he took photographs of the document to prove that he had this against Laura but denied ever posting those photographs to Reddit. Greg denied having any contact with her and told me the last time he ever had contact with Laura was sometime around August 2021. Gregory advised me that he had nothing to hide and would be fine answering any further questions I had.

Gregory went on to tell me that Laura currently has a civil lawsuit filed against him and Clayton Echard, . Gregory told me that he believes Laura is doing these things to get at him during their ongoing civil lawsuit.

This concludes my involvement in the situation.
