**MOTION TO WITHDRAW AS
ATTORNEY OF RECORD**

COMES NOW Defendant, Laura Michelle Owens, through counsel, and pursuant to *Ariz.R.Crim.P.*, Rule 6.3(c)(2)(B), respectfully moves this Court for an Order allowing Joshua Kolsrud, Sandra Schutz, and Kolsrud Law Offices to withdraw as attorneys of record in this matter.

Professional considerations require termination of representation pursuant to Arizona Rules of Professional Conduct E.R. 1.16. *See Maricopa County Public Defender v. Super. 3 proceedings.¹
