FRAUD BOMBSHELL Bachelor Clayton Echard's ex-fling has admitted to 'fraud and forging pregnancy records' after paternity test scandal

The anonymous woman claimed she had a one-night stand with Clayton that allegedly led to her becoming <u>pregnant</u>.

On August 1, she filed a lawsuit in an Arizona family court demanding he take a paternity test after he didn't believe he was the father of her twins.

He actively fought against the accusations and denied ever sleeping with the woman.

In December, the woman said she was no longer pregnant, but no more details were released.

On Thursday, Reality Steve posted a statement on \underline{X} , formerly known as Twitter, from Clayton that stated she was never pregnant.

The statement claims that the woman admitted to altering medical records that claimed she was pregnant.

The statement also claims that: "Claims of a doctor 'confirming' the pregnancy are patently false.

"A tele-med (video) appointment with a neurologist is not pregnancy confirmation."

It also stated that there would be no proof of a "high-risk" pregnancy because "no obstetric care was ever sought."

BEFORE THE CONFIRMATION

In January, Clayton's ex-fling claimed <u>she's no longer pregnant</u>, The U.S. Sun can exclusively reveal.

Four months after he was <u>accused of fathering the woman's unborn</u> <u>twins</u>, she made a bombshell claim in an Arizona court filing.

On December 28, the former <u>Bachelor</u>'s ex-fling filed a motion to dismiss with prejudice her petition that was initially filed in August to establish paternity, legal decision-making, parenting time, and child support.

With prejudice means the case can be dismissed permanently and not be brought back to court.

According to court docs exclusively obtained by The U.S. Sun, the Petitioner claimed she was no longer pregnant.

The 33-year-old <u>podcast</u> host from Scottsdale, <u>Arizona</u>, noted in the docs: "Petitioner acknowledges that she is no longer pregnant with Respondent's child, meaning there is no paternity to establish."

She continued: "There is nothing left for this Court to adjudicate, and this case should be dismissed."

The Petitioner further described her current state as "not now pregnant."

She initially said she expected to give birth to twins on February 14.

There was no explanation given as to what had happened during the supposed pregnancy.
