IT IS ORDERED setting a Complex Case Management Conference on 09/25/2025 at 9:10 a.m. before this Division.

IT IS ORDERED vacating the Final Trial Management Conference on 10/16/2025 and resetting same on 01/15/2025 at 9:00 a.m. before this Division.

IT IS ORDERED vacating the Trial Assignment date of 10/23/2025 and resetting same on 01/22/2025 at 9:00 a.m. before the Master Calendar Assignment Judge. The Trial Assignment hearing is in person for all lawyers and defendants. The parties should contact the Trial Assignment division prior to the Trial Assignment date to request to appear virtually. The purpose of the hearing is to set dates for (1) the Trial Procedure Conference and (2) the jury selection date.

All self-represented litigants shall appear in person at the trial assignment date unless otherwise ordered. All in custody defendants shall be transported unless otherwise ordered.

 - 14. Settlement conference date;
 - 15. Interpretation, translation and transcription needs;
 - 16. Schedule of regular Case Management Conferences.

At the Scheduling Conference, the Court will set a Trial Date and Case Management Conference schedule. Case Management Conferences will be presumptively set every 45 to 60 days, or more or less frequently as circumstances dictate.

The lawyers who will try the case and the defendant(s) shall attend each Case Management Conference unless previously excused by the Court. The purpose of the Case Management Conference will be to review pretrial preparation to date, resolve issues, and schedule activities to be accomplished before the next Case Management Conference.

JOINT CASE MANAGEMENT REPORTS:

No less than two working days before each Case Management Conference, the parties shall file a Joint Case Management Report. This report will inform the Court of:

- 1. The specific progress made since the last Case Management Conference in completing activities previously established by the Court and the parties;
- 2. Specific case preparation to be completed before the next Case Management Conference;
 - 3. Witnesses who have been interviewed in the preceding month;
 - 4. Witnesses who will be interviewed in the upcoming month;
 - 5. Pending issues to be resolved.

IT IS FURTHER ORDERED affirming prior release orders.
