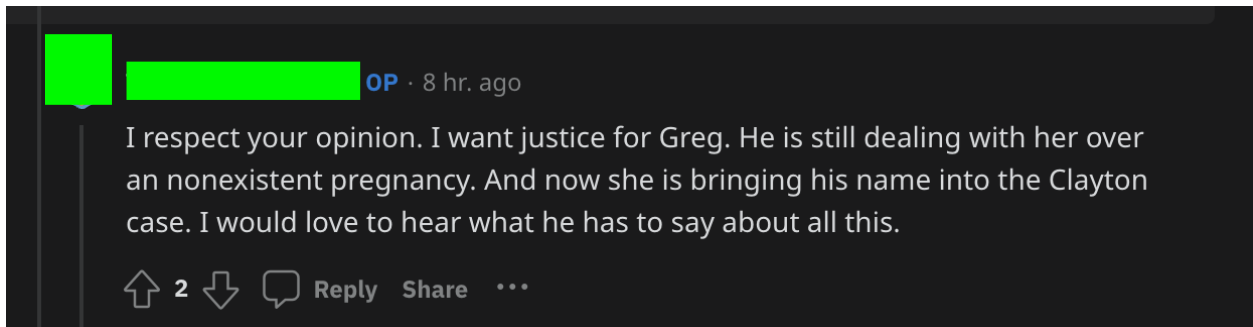


THE GILLESPIE CONNECTION:

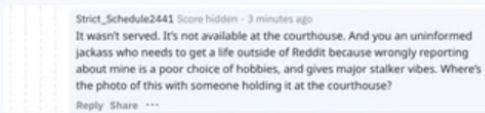

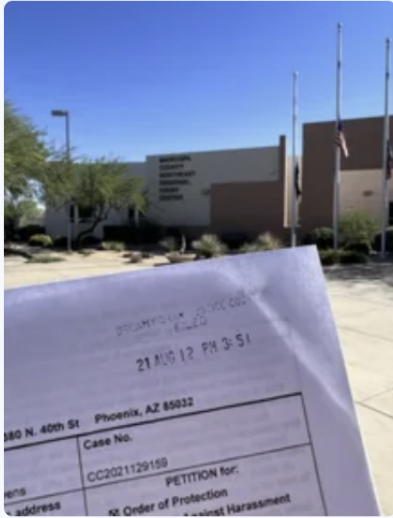

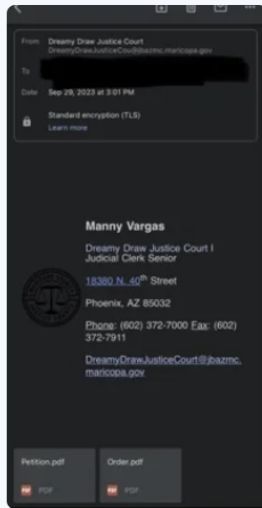
