On the listed date and time Laura Owens called to report a harassment against a former one night stand named Clayton Echard. She said he was on ABC's "The Bachelor" reality TV show and he has a lot of followers on Instagram. She said she is involved in a civil matter with him where he is going to take a paternity test to figure out whether her unborn twins are his. He has posted on social media that Laura has done this to other men before and that what she is claiming is not true. She said since he has so many followers people will believe him and she feels this is harassment. I explained to her this does not meet the threshold of anything criminal in nature and that if she has a complaint to contact a civil attorney to decide how to proceed. She asked that I document this incident and I explained that I would. She also requested I call Clayton and provided his phone number and ask him to leave her alone.

I called Clayton and spoke with him on the phone. He told me that Laura is in no danger from him and that is will try to avoid her at all costs. He believes she has tried to extort men in the past who she claimed she was pregnant by and he feels this harassment will never end. I told him I was not calling him because of a police matter but literally as a courtesy to Laura. He told me not to worry and that he would not contact Laura for any reason.

This is a civil matter. NFI.
