**NOTICE OF INTENT TO DISMISS CASE**

**NOTICE AND WARNING:** The Court Information System indicates that at least 120 days have passed since your case was filed on 08/01/2023, and no trial, hearing, conference or Motion to Set is pending. - If you do not wish to have your case dismissed for lack of prosecution, you must take one of the following actions:

*If you need more time to complete your case, you may file a Motion to Extend the Dismissal Date (<https://superiorcourt.maricopa.gov/media/4457/dr15fz.pdf>). The judge must sign the order granting your motion prior to the dismissal date above.*

*If an answer has been filed and both parties are representing themselves, complete and submit a Request to Schedule an Early Resolution Conference prior to the dismissal date above ([https://superiorcourt.maricopa.gov/media/1738/request\\_for\\_erc.pdf](https://superiorcourt.maricopa.gov/media/1738/request_for_erc.pdf)) or contact Family Administration (602-506-1561) for more information.*

*If an answer has been filed and at least one party is represented by a lawyer, you must file a Motion to Set Trial Date prior to the dismissal date above (<https://superiorcourt.maricopa.gov/media/4183/drtp5z.pdf>)*

*If an answer has not been filed, you must have (1) a default hearing scheduled OR (2) submitted all paperwork (Motion to Proceed without Hearing AND proposed Decree/Judgment), prior to the dismissal date above.*

*Have a final decree or judgment signed by a Judge or Commissioner prior to the dismissal date above.*

**WARNING: THE COURT WILL DISMISS YOUR CASE without prejudice unless you take action by following the instructions listed above. "Dismiss" means there will be no court order granting or denying what you asked for in the court papers. "Without prejudice" means you can file the case again, but you might lose certain rights.
