- On August 16, 2021 at approximately 8:55 pm I arrived and saw the bottom of the blinds were lifted about 6 inches and there was a light on in the kitchen. I rang the bell and heard the dog and saw it in the living room. It was sitting and facing the kitchen. I rang the bell another 6-7 times and kept looking for movement in the house, under the blinds, but no one appeared.
- 6. I was told the Defendant was aware he was going to be served and has purposely avoided opening the door to anyone he doesn't know. It is my professional opinion that Gregory is evading service and I highly recommend Alternative Service where we can post it to the door.
 I DO NOT believe he will answer the door to anyone he doesn't recognize.
- This is considered to be personal service.
- The fee I charged for this service was \$55.
